Notice To Exhibitors

1. Conditional, unsigned, incomplete, or telephoned entries cannot be accepted. Entries without fees are not acceptable.
2. **PLEASE TYPEWRITE or NEATLY PRINT** all entries. Use black or blue ink as entries will be photocopied. DO NOT use pencil or colored ink to write entries.
3. **ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS** or photocopies of entry forms without the agreement and rules on the reverse side are NOT ACCEPTABLE.
4. **CHANGES**, additions, or corrections to entry forms must be received in writing prior to close of entries. Telephone changes are unacceptable.
5. **OWNERS OR THEIR AGENTS ARE RESPONSIBLE FOR ERRORS** on entry forms, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete. **FEES MUST ACCOMPANY ENTRIES.**
6. **ENTRY FEES WILL NOT BE REFUNDED** in event of errors or cancellation of entries after the published closing date and time, nor in the event a dog is absent, disqualified, sick, lame, in season, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. If, because of riots, civil disturbances, fire, Act of God, strikes, extreme weather conditions (including but not limited to extreme heat, floods, hurricanes, lightning, or earthquakes), or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.
7. **RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY.** The Treasurer will add a collection fee of \$20.00 plus bank fees to the amount of each returned check. Subsequent returned checks from the same exhibitors or agent may result in their being put on a cash-only basis.
8. **CONFIRMATION OF ENTRY & SCHEDULE OF JUDGING TIME** will be sent to the address on the Official AKC Entry Form after the closing date. If an exhibitor has not received a copy of the Schedule within seven days of the show, the Show Secretary should be contacted.
9. **PLEASE NOTE:** Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary one half hour prior to the start of any regular conformation judging at the show. (American Kennel Club Rule, Ch. 11, Sec. 6)
10. **DOGS NEED TO BE AT THE SHOW** only at scheduled time of judging and may leave immediately after unless required for further judging.
11. **DOGS MUST BE READY FOR JUDGING.** Owners or their agents alone are responsible for the presence of their dogs in the judging ring. Judges will not wait for any dog holding up a class.
12. **THE SHOW COMMITTEE WILL USE CARE** and diligence for the welfare of dogs and exhibitors but will not be responsible for, nor assume the responsibility in the event of an accident or misfortune to either dogs or exhibitors participating in this show. The welfare of the exhibitor's child is assumed to be the responsibility of the exhibitor. Please secure proper crates or means to confine dogs for the welfare of all concerned.
13. Only dogs that are eligible to be shown under the American Kennel Club Rules shall be allowed within the show precincts. Puppies under 6 months are not allowed.
14. An **AGENT** is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner to be handler or, and responsible for, the dog at the show. Agents' names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the services of such an agent should familiarize themselves with the requirements for professional group membership or certifications.

NOTICE – THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.

CLEAN-UP IS YOUR RESPONSIBILITY

Pooper-scoopers (in chlorine filled buckets) will be placed all around the grounds and outside all rings. If your dog soils the parking lot, show grounds or ring, it is your responsibility to clean it up. By signing the entry form at this show you are agreeing that all clean-up is your responsibility. Violators may be subject to an event committee hearing. Thank you for your cooperation.

Spayed bitches and castrated males are allowed in Veteran classes at independent specialties. Winners of the Veterans Dog & Bitch classes will compete for Best of Breed provided that they are undefeated in any Regular Classes at this show.

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed or Variety competition: Dogs that are Champions of Record, or Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the day of the show where a dog completed the requirements for a championship according to the owners' records.

SELECT DOG AND SELECT BITCH

At the judge's discretion, Grand Championship points may be awarded to: Best of Breed, Best of Opposite Sex, Select Dog, and Select Bitch. Dogs eligible for Grand Champion competition are Champions competing in BOB, move-ups to BOB, and Champions that win Non-Regular classes and become eligible for BOB. Altered or spayed CH veterans are eligible at independent specialties. Winners Dog and Winners Bitch are NOT eligible.

AWARDS OF MERIT

After awarding Best of Breed, Best of Winners, and Best of Opposite Sex, the Judge may present up to three (3) Awards of Merit at judge's discretion.

STUD DOG CLASS, for Dogs that have sired two dogs or bitches entered in this show. The Get is to be judged, not the Stud Dog. Owner of the Stud Dog need not necessarily be the owner of the Get. Stud Dog must be entered in the Stud Dog Class and be shown in the ring with his Get.

BROOD BITCH CLASS, for Bitches that have whelped two dogs or bitches entered in this show. The Produce is to be judged, not the Brood Bitch. Owner of the Brood Bitch need not necessarily be the owner of the Produce. Brood Bitch must be entered in the Brood Bitch Class and be shown in the ring with her Produce.

BRACE CLASS, for two Greater Swiss Mountain Dogs that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs must have at least one common owner.

As the judge's decision in the Stud Dog, Brood Bitch, and Brace Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged First in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

BEST BRED-BY-EXHIBITOR. Morning Show only. To be chosen from the winners of the Bred-By-Exhibitor classes. To be handled by the breeder-owner. If a BBE entry is chosen as BOB or BOW, then it is automatically Best BBE.

BEST PUPPY IN REGULAR CLASSES. Afternoon Show only. To be chosen from the winners of the Puppy classes (6-9, 9-12). If a Puppy Entry is chosen BOB or BOW, then it is automatically awarded Best Puppy.

Puppy Sweepstakes

Morning Show Only.

Classes to be divided by sex and age. All entries in Sweepstakes MUST be entered in a Regular class, and entries must be made at the same time and on the same entry form. Breed Standard of the Greater Swiss Mountain Dog

GENERAL APPEARANCE

The Greater Swiss Mountain Dog is a Draft and Drover breed and should structurally appear as such. It is a striking, tri-colored, large, powerful, confident dog of sturdy appearance. It is a heavy boned and well muscled dog which, in spite of its size and weight, is agile enough to perform the all-purpose farm duties of the mountainous regions of its origin.

SIZE, PROPORTION, AND SUBSTANCE

Height at the highest point of the shoulder is ideally: Dogs: 25.5 to 28.5 inches. Bitches 23.5 to 27 inches. Body length to height is approximately a 10 to 9 proportion, thus appearing slightly longer than tall. It is a heavy boned and well muscled dog of sturdy appearance.

HEAD

Expression is animated and gentle. The eyes are almond shaped and brown, dark brown preferred, medium sized, neither deep set nor protruding. Blue eye or eyes is a disqualification. Eyelids are close fitting and eyerims are black. The ears are medium sized, set high, triangular in shape, gently rounded at the tip, and hang close to the head when in repose. When alert, the ears are brought forward and raised at the base. The top of the ear is level with the top of the skull. The skull is flat and broad with a slight stop. The backskull and muzzle are of approximately equal length. The backskull is approximately twice the width of the muzzle. The muzzle is large, blunt and straight, not pointed and most often with a slight rise before the end. In adult dogs the nose leather is always black. The lips are clean and as a dry-mouthed breed, flews are only slightly developed. The teeth meet in a scissors bite.

NECK, TOPLINE, AND BODY

The neck is of moderate length, strong, muscular and clean. The topline is level from the withers to the croup. The chest is deep and broad with a slight protruding breastbone. The ribs are well-sprung. Depth of chest is approximately one half the total height of the dog at the withers. Body is full with slight tuck up. The loins are broad and strong. The croup is long, broad and smoothly rounded to the tail insertion. The tail is thick from root to tip, tapering slightly at the tip, reaching to the hocks, and carried down in repose. When alert and in movement, the tail may be carried higher and slightly curved upwards, but should not curl, or tilt over the back. The bones of the tail should feel straight.

FOREQUARTERS

The shoulders are long, sloping, strong and moderately laid back. They are flat and well-muscled. Forelegs are straight and strong. The pasterns slope very slightly, but are not weak. Feet are round and compact with well arched toes, and turn neither in nor out. The dewclaws may or may not be present.

HINDQUARTERS

The thighs are broad, strong and muscular. The stifles are moderately bent and taper smoothly into the hocks. The hocks are well let down and straight when viewed from the rear. Feet are round and compact with well arched toes, and turn neither in nor out. Dewclaws should be removed.

COAT

Topcoat is dense, approximately 1-1/4 to 2 inches in length. Undercoat must be present and may be thick and sometimes showing, almost always present at neck but may be present throughout. Color of undercoat ranges from the preferred dark gray to light gray to tawny. Total absence of undercoat is undesirable and should be penalized.

COLOR

The topcoat is black. The markings are rich rust and white. Symmetry of markings is desired. On the head, rust typically appears over each eye, on each cheek and on the underside of the ears. On the body, rust appears on both sides of the forechest, on all four legs and underneath the tail. White markings appear typically on the head (blaze) and muzzle. The blaze may vary in length and width. It may be a very thin stripe or wider band. The blaze may extend just barely to the stop or may extend over the top of the skull and may meet with white patch or collar on the neck. Typically, white appears on the chest, running unbroken from the throat to the chest, as well as on all four feet and on the tip of the tail. White patches or collar on the neck is acceptable. Any color other than the "Black, Red and White" tri-colored dog described above, such as "Blue/Charcoal, Red and White" or "Red and White" is considered a disqualification. When evaluating the Greater Swiss Mountain Dog, markings and other cosmetic factors should be considered of lesser importance than other aspects of type which directly affect working ability.

GAIT

Good reach in front, powerful drive in rear. Movement with a level back.

TEMPERAMENT

Bold, faithful, willing worker. Alert and vigilant. Shyness or aggressiveness shall be severely penalized.

SUMMARY

The foregoing is the description of the ideal Greater Swiss Mountain Dog. Defects of both structure and temperament are to be judged more severely than mere lack of elegance because they reduce the animal's capacity to work. Any fault that detracts from the above described working dog should be penalized to the extent of the deviation.

DISQUALIFICATIONS

Any color other than the "Black, Red and White" tri-colored dog described above, such as "Blue/Charcoal, Red and White" or "Red and White." Blue eye or eyes.

Schedule of Championship Points

The Points towards a Championship shall be awarded to the Winners Dog and Bitch, based on the actual number of dogs or bitches competing in that breed or variety. Only dogs entered and judged in the Regular Classes will be counted as being present for the purpose of Championship rating.

Any dog which shall have won fifteen points shall become a Champion of Record, if six or more points shall have been won at two shows with a rating of 3 or more Championship Points each and under two different judges, and some one or more of the balance of the points shall have been won under some other judge or judges than the two judges referred to above.
